ITEM NO. 1 – APPROVAL of JULY AGENDA

ITEM NO. 2 – APPROVAL of MAY 29, 2015 BOARD MINUTES

On a motion by **Dial**, seconded by **Deese**, the board unanimously approved the May 29, 2015 minutes as presented by Jackie McAuley, Administrative Assistant.

ITEM NO. 3 – APPROVAL of YEAR END FINANCIAL REPORT

Coordinator Hart explained to the board that the Division has released 30 percent of the District's upcoming expected Ag Cost Share Funds or approximately \$13,774. Upon approval of the State budget balance of the funds will be released. Hart also updated the Board on Inactive Waste Lagoon Closures and Technology Grants.

ITEM NO. 9 – ANYTHING for the GOOD of the DISTRICT

• The board agreed that Quick is able to take advantage of technical learning procedures outside of Richmond County without submitting a travel request. Any travel expenses would not be eligible for county reimbursement.

- McAuley presented a Resolution to Clarify Education Contest Rules and Guidelines for the board to review prior to the Fall Meeting.
- McAuley has been asked to accept the position of Area VII State Envirothon Alternate Representative. The board asked questions and discussed the issue. Joyner called for a motion. On a motion by Gainey, seconded by Dial, the board unanimously approved.
- Joyner summarized that the board has approved that McAuley can continue her Environmental Education classes with approximately 30 percent of her schedule being allocated to this program.
- Joyner stated that he expects McAuley to email out a weekly calendar to the board.
- McAuley offered to email out the Monday Morning Update email that she had created when she first started at the District in 2009.
